Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. Delivery of the Goods should be within twenty (20) calendar days upon receipt of the Notice to Proceed. Interested Bidders should have completed, within five (5) years from the date of submission and receipts of bids, a contract similar to a project.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country, the laws or regulations of which grant similar right or privileges to citizens, corporations or associations of the Philippines.

4. Interested bidders may obtain further information from the PPSC and inspect the Bidding Documents at the address given below during office hours starting from 8 a.m. to 5 p.m. A complete set of Bidding Documents may be purchased by interested Bidders starting 26 MARCH 2013 from the address below and upon payment of a non-refundable fee to the PPSC Cashier. It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the PPSC website at www.ppsc.gov.ph, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the deadline for the submission of bids.

5. The PPSC will hold a Pre-Bid Conference on 03 April 2013, at 9:30 a.m, at PPSC Conference Room, 5/F Commerce and Industry Plaza, Mckinley Town Center, Fort Bonifacio, Taguig City which shall be opened only to all interested parties who have purchased the Bidding Documents.
