



SUBJECT : Instruction to Bidders

To : All Qualified Bidders

1. Only Bidders with updated Business Permit, Department of trade and industry Certificate, Mayors Permit and Other allied business documents are authorized to participate in the public bidding. Prospective Buyer/Bidders must submit an affidavit of Ocular Inspection of BER from the designated depot and BIR Certificate with Tax Identification number or Tax Account Number.

2. The minimum amount for the bid proposal on the specific lot shall not be less than the amount as determined by the PNPA Disposal Committee based on the Commission on Audit-Policy Training and Technical Assistance Facility (COA-PTTAF) Manual on Disposal.

3. Bidders with total highest calculated and complying bid proposals for each lot designated will be declared as winning bidder/s.

4. The ten (10%) percent bid value deposited by the awardee shall automatically converted into partial payment and failure of the awardee to remit/pay the balance of the amount of the bid on or before 2:00 O'clock in the afternoon of the third working day from the date of the sale will render the award null and void and the ten (10%) deposited shall be forfeited in the favor of the PNP.

5. Bid bond could either be value amounting to five (5%) percent of the total bid amount should be in the form of cash, or the value amounting to ten (10%) percent if in a form of Manager's Check or Bond Premium from AFP GIC, GSIS or any Bonding Institutions. This bid bond (with corresponding official receipt in case of bond premiums) should be dropped together with the bid proposal during the public bidding. Bid bond for a particular lot which deposit shall be returned to the losing bidder after the award is made.

6. The opening of bid tenders shall be done by the PNPA Disposal Committee and may be witnessed by the bidders or their duly designated representatives.

7. Hauling and transfer of BER equipment's from the PNP Depot shall be the responsibility and at the cost of the winning bidder/s.

8. Winning bidder/s upon receipt of Notice of Award shall pay the total bid amount at the office of FSO 18 PNPA.

9. Notice to Proceed (for withdrawal/hauling) will be issued by Philippine National Police Academy (PNPA) to the winning bidder/s upon presentation of official receipt issued by the FSO 18 PNPA.

10. Storage fee shall be imposed on the items awarded not claimed within ten (10) days from the date of sale. Items unclaimed after twenty (20) days from the date of sale/award will be rebid and all moneys including the ten (10%) percent bid deposit will be considered forfeited.

11. All of these terms and conditions shall be incorporated in the Notice to Proceed.


12. Three (3) copies of the bid proposal, bid bond and the copy of this instruction duly acknowledge should be included in One (1) sealed envelope to be submitted on or before the scheduled date stated in the Invitation to Bid.

13. Particular relative to the disposal procedure, bid bond, bid evaluation and awards shall be governed by PD1445, Sec79-Government Auditing Code of the Philippines, other COA Guidelines on the Review of Appraised Value of Disposed Property and Appraisal of Property and other applicable rules and regulations.

14. The PNP reserves its right to reject any or all bids, waive any defect contained therein, and accept the offer most advantageous to the government.
