**INVITATION TO BID FOR THE PROCUREMENT of Castañeda Executive Suite
Furniture and Fixtures
(PNPA SUPPLIES 2024-28)**

1. The *Philippine National Police Academy* through the PNP Trust Receipt for the month of March 2024, intends to apply the sum of **Three Million One Hundred Sixty-Seven Thousand Two Hundred Pesos (PhP3,167,200.00)** being the Approved Budget for the Contract (ABC), to payments under the contract for the **Procurement of Castañeda Executive Suite Furniture and Fixtures under Public Bidding PNPA SUPPLIES 2024-18**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Philippine National Police Academy* now invites bids for the above Procurement Project. Delivery of the Goods is required within 7 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from the **PNPA BAC Secretariat** at the address given below from **8:00AM to 5:00PM Monday to Friday except on Holidays**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 21, 2024 to September 10, 2024** from the given address and website(s) below upon payment of non-refundable fee in the amount of **Five Thousand Pesos (PhP5,000.00)** The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.
6. The **Philippine National Police Academy** will hold a Pre-Bid Conference on **August 29, 2024 (Thursday) at 10:00 AM PNPA Conference Room at Camp Gen. Mariano N. Castañeda, Brgy. Tartaria, Silang, Cavite** and/or through video conferencing or webcasting *via Zoom*, which shall be open to prospective bidders.



7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **September 10, 2024 (Tuesday) at 10:00AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **September 10, 2024, 10:00 AM** at the given address below and/or through video conferencing or webcasting *via Zoom*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Philippine National Police Academy** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
