**INVITATION TO BID FOR THE COMPLETION OF PNPA MESS HALL (PHASE 2)  
(PNPA INFRA 2022-016)**

1. The Philippine National Police Academy, through the GAA FY 2022 dated January 3, 2022 intends to apply the sum of **Twenty-Nine Million Nine Hundred Seventy-Eight Thousand Pesos [Php29,978,000.00]** being the Approved Budget for the Contract (ABC) to payments under the contract for the Completion of PNPA Mess Hall (Phase 2) **under Public Bidding No. PNPA INFRA 2022-016**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Philippine National Police Academy* now invites bids for the above Procurement Project. Completion of the Works is required within **390 calendar days** upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Philippine National Police Academy Bids and Awards Committee Secretariat* and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM except on holidays**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **July 5, 2022 to July 26, 2022** from the given address and website/s below upon payment of a non-refundable fee in the amount of **Twenty-Five Thousand Pesos [Php25,000.00]**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.
6. The *Philippine National Police Academy* will hold a Pre-Bid Conference on **July 13, 2022 (Wednesday) at 2:00 PM at the PNPA Main Conference Room, 2<sup>nd</sup> Floor PNPA Admin Building, Camp General Mariano N Castañeda, Silang Cavite** and/or through videoconferencing/webcasting via Zoom which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat **through manual submission at the office address as indicated below**, on or before **July 26, 2022 (Tuesday) at 9:00 AM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.
9. Bid opening shall be on **July 26, 2022 (Tuesday) at exactly 9:00AM at the PNPA Main Conference Room, 2<sup>nd</sup> Floor PNPA Admin Building, Camp General Mariano N Castañeda, Silang Cavite**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Philippine National Police Academy** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
