INVITATION TO BID
FOR THE PROCUREMENT, DELIVERY, INSTALLATION, AND
COMMISSIONING OF HEAVY-DUTY EQUIPMENT AND TOOLS FOR
THE NEWLY CONSTRUCTED MOTOR POOL
(PNPA EQUIPMENT-2026-19)

- 1) The *Philippine National Police Academy (PNPA)*, through the Approved Program of Expenditures – Programmable Amount (POE-PA) of the PNP Trust Receipts for August 2025, intends to apply the sum of **Two Million Six Hundred Fifty-Three Thousand Three Hundred Forty-Nine Pesos (PhP2,653,349.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement, Delivery, Installation and Commissioning of Heavy-Duty Equipment and Tools for Newly Constructed Motor Pool**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The *PNPA* now invites bids for the **Procurement, Delivery, Installation and Commissioning of Heavy-Duty Equipment and Tools for the Newly Constructed Motor Pool** using the *Lowest Calculated and Responsive Bid (LCRB)*. Delivery of the Goods is required *thirty (30) calendar days*. Bidders should have completed, at least 2 years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4) Interested Bidders may obtain further information from the **PNPA BAC Secretariat** and inspect the Bidding Documents at the address given below from **8:00 AM to 4:00 PM from Mondays to Fridays except on weekends and holidays**
- 5) A complete set of Bidding Documents may be acquired by interested Bidders from **April 14, 2026 to May 5, 2026**, from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (PhP5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The *PNPA* will hold a Pre-Bid Conference on **April 21, 2026 (Tuesday)**, at 2:00 PM, at the *PNPA* Conference Room at *Camp General Mariano N Castañeda, Brgy. Tartaria, Silang, Cavite* and/or through video conferencing, which shall be open to prospective Bidders. Zoom Details:

- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below, on or before **May 5, 2026 (Tuesday)**, at 2:00 PM. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
- 9) Bid opening shall be on **May 5, 2026 (Tuesday)**, at 2:00 PM at *Conference Room 2nd Floor Administration Building Camp General Mariano N Castañeda, Silang, Cavite*. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) The *PNPA* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70⁴ of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
